Pippinfest is a juried show for handmade or self-created products. This year Pippinfest is seeking Colonial and Folk Art vendors and demonstrators to create a Colonial Corner on the streets close to the Historic Fairfield Inn. The Colonial Corner will be advertised as a special feature on SUNDAY, along with musical entertainment and a car show. Please note that on SATURDAY, Pippinfest has primarily yard sales tables, the kids corner and a few vendors. You are most welcome to participate on Saturday, as well.

Colonial/Folk Art Vendors/Demonstrators are required to wear colonial apparel. If you are demonstrating only (without making sales), there is no fee but you must submit an application. If you are selling colonial crafts or folk art, you must demonstrate as well to qualify for the \$50 per day fee.

The festival is held rain or shine. Hours are 9:00 a.m. to 4:00 p.m. on Saturday and Sunday. You must keep your booth set up for the duration of the show even if you sell out, unless closure becomes necessary due to extreme weather conditions. Vendors new to Pippinfest must submit 2 photographs. Returning vendors need to send photographs only of new items. **Quality retail products will be accepted on a limited basis.** List ALL crafts and/or products you plan to sell below; use the back or another sheet of paper if needed.

Please make checks payable to **Pippinfest** and include a check with the signed application. The prices below are per space. **Applications postmarked after September 1 may be subject to a penalty fee. NON-PROFIT GROUPS & RESIDENTS PLEASE NOTE:** Although Pippinfest does not impose a fee on non-profit organizations and Main Street residents, a donation to help offset advertising and festival costs is reasonable and appreciated.

Please submit your application ASAP so we can start promoting the vendors and demonstrators in the Colonial Corner.

The Colonial/ Folk Art Space is a single space 12' w and 20' d (twice the size of the standard vendor space) which allows room to do demonstrations. Colonial Canopies are not required, but would be welcome if you have them. If using a canopy (regular or colonial), you must provide its size here: _____ft. X _____ft. Canopies, chairs, tables and electricity are **not** provided. **Any vendors needing electricity should provide their own generators or make arrangements with the property owners prior to the event.** Spaces must be used by the approved vendors, and vendors must display only crafts/products that have been approved.No space can be shared or subcontracted to another vendor.
