Neighborhood Meetings Guest Speakers

We only have 3 neighborhood meetings left, before the summer break.

Fire Safety

Nearly 4,000 Americans die every year in house fires. Smoke alarms can give you crucial early warning time to get out of the house in time. A working smoke alarm can double your chance of surviving a fire in the home.

Install smoke alarms:

- in each bedroom
- in the hallway close to each sleeping area and
- in heavily occupied areas like the living room
- on each level of your house is the absolute minimum

Smoke alarms should be placed on or near the ceiling where smoke tends to accumulate:

- Install smoke alarms 8 to 10 inches away from corners and walls
- Install the alarms high, because smoke rises
- Install smoke alarms at least three feet from vents, which might re-circulate the smoke
- Never place smoke alarms on un-insulated walls or ceilings. Extreme temperatures can ruin batteries and prevent smoke from reaching the alarms
- Never place smoke alarms directly over stoves, ovens, or fireplaces

Take care of your smoke alarms:

- Test your smoke alarm at least once a month by pressing the test button
- Replace weak or worn-out batteries
- Change batteries at least once a year
- Dust and vacuum smoke alarms at least once a year
- Replace smoke alarms every 10 years
- Make sure smoke alarms are working when you return home after an extended absence

Need help installing an alarm? The City of Austin's free smoke alarm program provides smoke alarms and assistance with installation to people residing in privately owned homes and have a genuine need for assistance. Call (512) 974-0299 for more information.

Seventy people are killed in wrecks in an average year in Austin, and many more are hurt. Speeding is a factor in almost a third of crashes, and pedestrians are most at risk. Higher speeds boost the risk that a pedestrian will be killed or hurt in a wreck.

A recent city speed study on Coronado Hills Drive

found that cars were going an average speed of 39 miles per hour, well above the speed limit. Slowing down a little will hardly make a difference travel time, but it could save a life.
