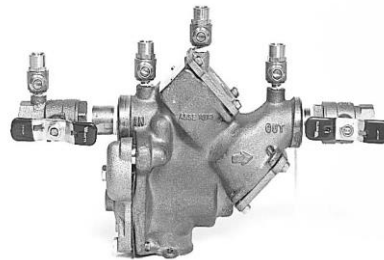

You will receive an “OTCO Certificate of Competency” and Student Identification Card upon successful completion of the course. Keep these as the documentation for your Ohio EPA contact hours. You may also print a copy of your accumulated OTCO contact hours from the OTCO website at ohiowater.org. You will need to enter your OTCO student number and pin number to obtain a copy of your contact hours.

OHIO DOC CERTIFICATION

If you pass this course, you may be eligible to sit for the Ohio Department of Commerce “Certified Backflow Technician” exam. The intent is to create an equal standing between the plumbing industry and the water supplier who must administer the local backflow prevention program.

For this reason the Ohio DOC certification will be unrestricted, but a water supplier must not openly compete with the plumbing industry by testing private isolation principle backflow prevention devices. The water supplier can test only the isolation devices that are located within their city-owned buildings.

Upon successful completion of the Backflow Prevention or Backflow Refresher course, your Instructor will give you an application to submit to the Operator Training Committee of Ohio, Inc., with the applicable fees, if you wish to take the Ohio DOC “Certified Backflow Technician” exam.
