#### Sugar Land Parks Guidelines – March 24, 2020

We appreciate the physical and mental health benefits that parks help provide, and we also recognize the need to prevent the spread of COVID-19. With this in mind, the following guidelines have been put in place. While we want our community to continue to use our parks and trails, failure to comply with the below guidelines may result in further park closures.

- All park playgrounds and restrooms are closed until further notice.
- The virus can stay on surfaces for several hours and playgrounds and restrooms cannot be constantly disinfected.
- The Pawm Springs Dog Park at Memorial Park and the skate park at City Park are closed until further notice.
- Additionally, the following park amenities are closed until further notice:
- o Picnic pavilions and all picnicking facilities
- o Park benches

# Solid Waste, Recycling, Green Waste and Textile Collection Updates – March 24, 2020

Textile collection update

Simple Recycling provides textile collection to all residents, including those in Greatwood. Effective immediately, textile collection services for all City residents will be suspended until further notice.

# Important solid waste program update for Republic Services customers:

Republic Services is experiencing an increase in the amount of residential solid waste as a result of residents spending more time at home. In an effort to mitigate these increases, while facing the challenges and limitations created by COVID-19, the following modifications will take effect Monday, March 30, 2020 and will remain in place until further notice. These modifications are temporary and full collection services will be restored as quickly as possible.

Bulky waste will be suspended until further notice.

- o Drinking fountains
- o Basketball courts
- o Tennis courts
- o Outdoor fitness equipment
- The city's two splash pads were scheduled to open in April; however, they will remain closed until further notice.
- Do not use parks or trails if you are exhibiting any symptoms.
- Follow CDC's guidance on personal hygiene prior to and during use of parks or trails.
- Follow CDC guidance on the recommended size of social gatherings including outdoor picnicking; pick-up sports games including but not limited to soccer, softball and volleyball; play dates and other group hangouts; and maintain proper physical distance at all times.
- Observe CDC's minimum recommended social distancing of 6 feet from other individuals at all times. If this is not possible, users should find an alternate location or depart that space.
- While on trails, warn other users of your presence and step aside to let others pass.

All other collection services will continue to run according to schedule with the following changes:

- Residents should continue placing their recycling and garbage carts out for service according to their normal collection schedule; however, due to the need to reallocate collection resources, recyclable material will not be recycled at this time. As this is a temporary change, we encourage residents to continue practicing good recycling habits to ensure a seamless transition once normal operations resume.
- Green waste collection will continue, however we anticipate delays in service. By taking the following steps, residents can help minimize these delays:
- o Mulch leaves and grass clippings instead of bagging them for disposal.
- o Limit the amount of pruning and aesthetic tree trimming to only what's essential.
- o If utilizing a landscape company, ensure that all green waste is collected and hauled off by the contractor.

#### Stay Home Orders Issued for Fort Bend & Harris Counties; Additional MCTX City Facilities to Close Through April 3

As the world continues to fight the Coronavirus pandemic, MCTX is monitoring the trajectory of the cases in our region and is working closely with local, state and national officials to implement proactive measures to ensure the safety of our residents.

Fort Bend County announced its "Stay Home to Save Lives" order which will go into effect through 11:59 p.m. Friday, April 3. Harris County issued a similar order "Stay Home, Work Safe". Both orders mandate that citizens:

Stay home and work safe at their place of residence

Leave their residences only for essential activities

Follow social distancing of at least six feet if using outdoor spaces like parks, grocery stores

The orders also:

Prohibit all public or private gatherings of any number of people

Close all businesses other than those that fall under essential businesses which includes, healthcare operations, government functions, critical functions and retail stores.

Allow restaurants to continue to provide take out, delivery, or drive-thru services.

Encourage religious and worship centers to provide video or teleconference services and limit staff to 10 people or less.

All individuals living within Fort Bend County are ordered to stay at their homes unless they are leaving for essential activities, essential government functions or to operate essential businesses.

You may still go to the grocery store and restaurants ("to-go" and curbside, orders only) exercise outside and go to work at businesses considered essential.

# Richmond Wastewater Representatives Warn of Clogged Pipes and Sewer System

We appreciate that citizens are following guidelines with use of wipes and disinfecting surfaces with paper towels; however, we need to remind everyone wipes and paper towels cannot be flushed down toilets because they clog the sewage system. Even flushable wipes are not flushable- they do not break down in the pipes like they are advertised to do.

People nationwide, including in Richmond Texas, are having to use other products due to shortage on toilet paper, so we need to realize none of these other products can go into the toilets. Anything other than toilet paper needs to go into a trash bag- not the toilet. Wastewater representatives are educating us that even facial wipes don't break down like toilet paper and can add to clogged pipes. Keep a trash bag in your bathroom and put all other products into the trash bags.

Let us all do our part and keep our pipes unclogged and our sewage system operating properly for everyone. Wastewater treatment professionals are reminding us all by using the hashtag #WipesClogPipes.

#### Frequent Questions to Richmond's Stay At Home Order

This action orders the following:

- All individuals currently living within the City of Richmond to remain at their place of residence unless engaging in essential business.
- All businesses, except essential businesses should cease all activities at facilities located within the City of Richmond
- All public or private gatherings of any number of people occurring outside a single house or living unit are prohibited
- Restaurants may only provide take-out, delivery, or drive-through services as allowed by law.
- Religious and worship services may only be provided by video and teleconferencing while limiting in-person staff to ten people or less
- All elective medical, surgical, and dental procedures are prohibited anywhere in the City of Richmond.

#### **Frequently Asked Questions**

- 1. Can I still go to the grocery store?
- Shopping for groceries would be considered an essential activity and should be done during store hours.
- 2. My business delivers to restaurants in the Richmond/Rosenberg area, can I work? Businesses that supply other essential businesses with support or supplies needed to operate, including employment agencies are allowed to operate.
- 3. If we are we going under lockdown at midnight and I have to go to work in the morning, what should I do? If you are not performing an essential activity or reporting to a business that has been identified as essential in the "Stay at Home Order", then we are asking that you remain at home so that we limit the number of possible exposures.

This is in effect until 11:59p on April 1, 2020 unless otherwise modified. This applies to all incorporated and unincorporated areas of Fort Bend County.

# FBI SEES RISE IN FRAUD SCHEMES RELATED TO THE CORONAVIRUS (COVID-19) PANDEMIC

Scammers are leveraging the COVID-19 pandemic to steal your money, your personal information, or both. Don't let them. Protect yourself and do your research before clicking on links purporting to provide information on the virus; donating to a charity online or through social media; contributing to a crowdfunding campaign; purchasing products online; or giving up your personal information in order to receive money or other benefits. The FBI advises you to be on the lookout for the following:

Fake CDC Emails. Watch out for emails claiming to be from the Centers for Disease Control and Prevention (CDC) or other organizations claiming to offer information on the virus. Do not click links or open attachments you do not recognize. Fraudsters can use links in emails to deliver malware to your computer to steal personal information or to lock your computer and demand payment. Be wary of websites and apps claiming to track COVID-19 cases worldwide. Criminals are using malicious websites to infect and lock devices until payment is received.

- Phishing Emails. Look out for phishing emails asking you to verify your personal information in order to receive an economic stimulus check from the government. While talk of economic stimulus checks has been in the news cycle, government agencies are not sending unsolicited emails seeking your private information in order to send you money. Phishing emails may also claim to be related to:Charitable contributions
- General financial relief
- Airline carrier refunds
- Fake cures and vaccines
- Fake testing kits

Counterfeit Treatments or Equipment. Be cautious of anyone selling products that claim to prevent, treat, diagnose, or cure COVID-19. Be alert to counterfeit products such as sanitizing products and Personal Protective Equipment (PPE), including N95 respirator masks, goggles, full face shields, protective gowns, and gloves.
