Booth Details:

- Fees must be paid by January 15, 2026 to guarantee your space for the 2026 Quilt Show.
- \$150.00 - Single booths are approximately 10' x 12' and include (2) chairs and (2) 6' tables
- \$250.00 – Double booths are approximately 10' x 24' and include (4) chairs and (4) 6' tables.
- Booths are indoors and the Community Center is air conditioned, electricity, and WIFI are available.
- There are no poles or drapes provided by Quilts in the Boro.
- Booths are assigned on a first come first serve basis.
- Booths cannot be sublet without the permission of the Quilts in the Boro Management.
- No pets allowed.

Additional Vendor Rules / Information:

- All Vendors must submit a Vendor Application.
- Participation is not guaranteed from year to year.
- This is a rain or shine event. No refunds due to the weather.
- If unable to attend the show, a partial refund may be made if notified by January 30, 2026 and the booth can be rented to another user.
- Water, coffee and snacks will be provided by the Quilting Bees at no cost.
- There will be an area for demonstrations. Each booth will have a 30-minute timeframe for any demonstrations. (Let us know if you need longer than 30 minutes.) Vendors will be contacted for dates/times if indicate they are interested below.
- The Vendor is responsible for any loss, theft or damage to their property. The Quilting Bees and Quilts in the Boro are not responsible for any losses or damage.
