The Sheriff also uses it to help supplement his County Revenue Budget. This tax is not available to be used in any other County except for the County the tax was passed in.

West District Commissioner, Kyle White attended at Region D meeting on Thursday April 8.

Sheriff Kasey Keesaman and Captain Mike Marvin met with the Commission to discuss hiring personnel and vehicles.

Bids for tubes were opened up at 11 a.m. with Brian Testerman of Metal Culverts in attendance as well as Randy Dillon of Viebrock. West District Commissioner, Kyle White made the motion to accept a portion of the bids from both vendors with East District Commissioner, Chet Owen making the second. All in favor. White, aye, Carroll, aye and Owen, aye. Motion carried. County Clerk, Melissa Meek will send in writing the bid acceptance letter to both Randy and Brian.

The Commission continues to look at ways to utilize space in the Courthouse.
