- Makeup Artist and/or Hair Stylist shall perform the services promptly on the date and time agreed.
- If Lisa's Country Cuts & Spa is unable to perform the agreed services for any unforeseeable reason or unavoidable situation, due to unforeseen circumstances or any other cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with respect to the agreement.
- Artist shall be the exclusive Makeup Artist for the Brides wedding.
- Lisa's Country Cuts & Spa shall use their own products in the provision of the services.
- Makeup Artist and Hair Stylist will use good quality professional materials.

Deposit

Prior to the wedding, Lisa's Country Cuts & Spa will perform the "Trial Run" to determine makeup colors, and hair styling per the requirements of the client. Upon receiving a 30% deposit, this will be considered a booking and guarantees your date. This deposit **NON REFUNDABLE**. 40% is due at Trial runs for hair and make up. If the Trial Run deposit is paid and the trial runs are not complete up to 1/2 of trial run deposit can be refunded. If the Trial runs are complete, the trial run deposit is **NON REFUNDABLE**. Final 30% is due one week prior to the wedding day. If final deposit is paid services are cancelled 30 days prior to wedding date up to 1/2 of the deposit can be refunded. After 30 days all deposits are **NON REFUNDABLE**. Deposits are applied to the balance, and Deposits can be paid with credit card, cash or check at Lisa's Country Cuts & Spa.
