- Each entry must be signed by the dog's owner or agent
- Handlers in good standing with AKC are welcome.
- No refunds will be given in the event of cancellation or if the match cannot be completed due to circumstances beyond our control.
- \$35 service charge for returned checks.
- Unsportsmanlike conduct, rudeness to our volunteers, stewards, judges or other exhibitors will not be tolerated and your entry will be voided without refund.
- **Social distancing inside and outside the rings will be enforced. If you are unable to abide by this please do not enter.**
- **This match is pre-entry only. Please limit the number of unentered people you bring with you.**
- **A run order will be sent out the night prior to the match. Plan to arrive in time for your class and leave after your run(s) is/are completed.**
