### APPROVAL OF MINUTES

She also thanked Julie Turnipseed for the Destination Business Workshop.

Commissioner Cole asked for an update on Henry Rockers dig at the South Lake. City Manager Weiner commented Henry completed his 3<sup>rd</sup> site excavation with two (2) or three (3) more to go.

Commissioner Cole asked what the plans were for the bridge at the North Lake. City Manager Weiner commented the City had spoken with two engineers about the project and different avenues such as installing box culverts, a railroad car, or a pipe.
