Course Description:

This **Non-Language Specific three (3)** CIMCE credit hour course will outline and familiarize the student with professional interpreter protocol used in conjunction with criminal investigations and other court and law enforcement protocol. Students will gain an understanding of a variety of criminal Investigation protocol, investigation specific terminology, and the type of situations and environments that demand specialized Investigators and Professional Interpreters. From interpreter assisted investigations and interviews, to the court room, this course will address the ever-present considerations needed for qualified Interpreters who assist in not only criminal Investigations, but also the many other areas that have a need for the professional interpreter. These areas also include, but are not limited to, forensic investigations, sexual assault investigations, death notification assistance, eviction proceedings, polygraph examinations, federal and state wiretap cases and traffic law to name a few. Other topics of discussion will include the initial mechanism involved in activating criminal investigation teams, Interpreter call-out considerations, Interpreter utilization and duties within a crime scene, critical aspects of criminal law regarding investigations and interpreting, Investigator/Interpreter case management, Interpreter preparation while responding to a crime scene, Interpreter safety while working within a crime scene and the resources available to Interpreters after utilization within a crime scene.

Jeff Torres is currently a full time Law Enforcement Professional with over 20 years of Law enforcement experience. His vast experience in many high-level felony investigations include, Homicide, Robbery, Narcotic, Sexual Assault and Death Investigation to name a few. Mr. Torres is currently a law enforcement Supervisor and brings to the classroom a clear picture as to the special dynamics and considerations inherent to current laws and judicial trends.
