RESOLUTION NO.: SL-31-2021

**TITLE: Approval of Contract with the University of Nevada, Reno for
Paleolimnology Study**

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation (“Reservation”) and to the long-term protection, preservation and management of these resources; and

WHEREAS, the Summit Lake Paiute Tribe has received funding to initiate a paleolimnology study in the Summit Lake watershed; and

WHEREAS, students and faculty at the University of Nevada, Reno possess the skills to carry out said research project; and

WHEREAS, the Summit Lake Paiute Tribe and University of Nevada, Reno have reached an agreement to work cooperatively together to initiate a paleolimnology study on the Reservation.

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves and consents to entering into the Research Agreement with the University of Nevada, Reno; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Tribal Council hereby authorizes the Tribal Chairwoman to execute the Research Agreement with the University of Nevada, Reno and any other instruments as may be necessary and appropriate to accomplish the above-mentioned action in the name of and on behalf of the Summit Lake Paiute Tribe.
