AMANA NEWS AND NOTES

CSA to be in Amana Oct 9 – 11
Plan to Take Part

Over 80 scholars from across the country will be here Oct. 9 – 11 for the annual conference of the Communal Studies Association.

The group will be meeting at the Amana Church in Amana and the Amana Heritage Museum in Amana. Everyone is welcome. To see a full schedule of events or to sign up to attend the full conference or any of the dinners or luncheons go to the communalstudies.org website “Annual Conference Registration” page.

If you wish to attend just one or two lecture sessions there is no charge.

A preconference tour will offer a closer view of Amana with tours of Amana Society businesses and meetings with members of the Amana Society, Inc. management team, a tour of Amana Farms and a visit to the methane digester. A tour of Amana historic sites will be offered on Thursday, then the conference officially begins with a welcome social hour at the Amana Heritage Museum on Thursday evening and two full days of lectures.

Lectures will be given at the Amana Church and the Amana Heritage Museum. In addition to presentations on Amana history, there will be over 40 papers given on a wide variety of topics. Several scholars will focus on 500 years of Hutterite history as the Hutterite's attain this major milestone.

Jason Stahl, of the Hutterite Way Pilgrimage Project will present Retracing the Hutterite Way: Embodied Pilgrimage as Communal Historiography. While Sibylle Becker Kilian of Kilian Architekten, Dresden Germany give a talk titled, From Cloistered Courts to Prairie Colonies: The Hutterites Five Centuries of Communal Architecture.

Among those presenting: Brian Carroll, House of David, giving a paper called, One Island, Two Communities: The House of David and the Anishinaabe on High Island, 1912-1928 and Carista Davis, Missouri State University, The Evolution from Seventh-Day Adventists to the Branch Davidians of Waco.

Jeff Bach, Young Center, Elizabethtown College, will present Pietists, Prophets and Celibates, Oh My! Christ's Assembly's Ohio Congregation at the Intersecting of Old and New Paths. While Dan McKanan, Harvard Divinity School, will present Sylvester Baxter's Path from Communalism to Forest Preservation. Thomas Guile of the Oneida Community Mansion House will discuss The Handcrafted Utopia: Arts and Crafts Communities in America's Progressive Era. Rick Marshall, University of Indianapolis, Shakers: Mindless Automaton or Autonomous Individuals?

REMINDER CONCERNING SOUTH DUMP

Iowa County Landfill accepts yard waste

What is commonly referred to as the South Dump, is **Private Property** and only for the use of **Amana Society Stock Holders** living within the Amana Colonies, and may be under 24 hour photo surveillance.

Burning is **absolutely not** permitted. Burning is dangerous and not compliant with DNR Regulations.

Only organic compostable yard refuse is allowed, and users **will** empty & remove plastic bags or other containers used to transfer yard waste. Lumber, and other building material, & trash dumping is absolutely **NOT** permitted.

Using this area to disposed of organic yard refuse is a privilege, not a right, and privileges will be revoked if Iowa Dept. of Natural Resources (DNR) and Amana Society rules on what may be disposed of or if the burning ban are violated.

If you witness violations of these rules, **please** report, to A.S.I. Conservation at 319-560-2459.
