Review School Districts Official Records

Board of School Trustees reviewed and discussed summary info of member district revenues, expenses, and fund balances for the month of January 2021. Treasurer Getty noted that member district fund balances are approximately \$23 million higher year-over-year. He also noted that year-over-year increase will be challenging for the LTTO to find depositories willing to take additional deposits and pay a competitive rate of interest.

Matters related to the possible withdrawal of Lyons Township High School District 204 from the Township Trustees of Schools, Township 38 North, Range 12 East, County of Cook, State of Illinois at the conclusion of FY2021

Treasurer Getty reported that he has not yet completed the expanded analysis of the LTTO’s books and records to identify if there were any allocations or misallocations of interest earnings and/or expenditures and if/how making adjustments/corrections would affect each of the LTTO Member Districts. This analysis will be presented at the March Board Meeting.

District 204 Litigation Update

Trial and witness testimony has been concluded and closing arguments are scheduled for Friday, March 12, 2021 at 11:00am. Closing arguments will be held via Zoom and the log in information for this date has been posted on the LTTO’s website. 

4. Adjournment.


Trustee Kantas moved to adjourn the Closed Session, seconded by President Thiessen. Closed session was adjourned at 6:33 p.m.
