**RMGA 2017 Nominations** 

RMGA Bylaws state that the Association President appoints the Nominating Committee consisting of at least three members. One of the members should be the Director-at-Large (a Past President). Larry Foos, Director-at-Large (a Past President), is the Chairperson, Nancy Brueggeman, Secretary, and Tom Jensen, Public Relations Committee Chairperson, are Nominating Committee members. They will contact the Association members to fill the necessary positions.

The RMGA Nominations and Election process is found in the RMGA Bylaws. Briefly, the procedure is:

\* When the slate of Nominations is completed, the **Committee presents the names of those nominees for Officers at the RMGA October Regular Membership Meeting**. Nominations are than opened from the floor. Nominations from the floor require the permission of the person you are nominating. When no further nominates are made, "<u>Nominations are Closed</u>".

\* The nominees are required to sign a commitment before the Annual November Membership Meeting and Election. They will follow the obligations of their Office, as stated in the RMGA Bylaws, to the best of their abilities if they are elected.

\* VOTING will be held at the Annual Meeting of the RMGA Membership (November 13, 2017). Voting Membership consist of Professional, Associate, and Business Members. We must have a quorum 20% of the voting members present to hold the election. **Your attendance is very important for the Election and the Program.** 

\* The Elected RMGA Board takes office January, 2018.

Rocky Mountain Guides Association, as a member of the National Federation of Tourist Guides Associations-USA, shares the goal of promoting the highest degree of professionalism for tour guides. A complete listing of the Code of Ethics and Standards is available on the RMGA website. Click on "About RMGA," then click on "Code of Ethics and Standards."

From time to time, a Standard is published in the *Guide Line* for RMGA members to consider for their professional growth. The Standard for October, 2017, is

1. A professional tourist guide provides a skilled, knowledgeable presentation; informs, interprets and highlights the surroundings; maintains objectivity and enthusiasm in a courteous and polite manner.

A professional tourist guide would be skilled in providing narrative that is neither too much, nor too little in information; that engages the listener, either in their mind or their body (or both); and that inspires the listener to pursue further exploration of the topic.

A professional tourist guide would be skilled in researching the information and comfortable conveying the content to the listener.

A professional tourist guide would be skilled in public speaking and the use of the various rhetorical devices.

A professional tourist guide would be skilled in remaining objective, neither glorifying the salacious nor minimizing the sensational.
