Zoning Officer Report: There is a report in the Boards packet.

Highway Superintendent Report: The union person called, the MOU was amended in the contract. Health Insurance amendment shows zero for the 6 months for the new employee. Mr. Cox is the new employee for the Highway Department.

Doing grader patch from Dunham Rd & Royce, to 20A to Royce in front of the Lodge. The second week in September helping Warsaw, Middlebury, and Attica. We received the insurance check, would like to put back in to highway budget. Mr. Roggow asked if Highway can put \$22,000, back into his budget from the sale of the truck.

On a motion from Mr. Herman, seconded by Mr. Boxler, to have money from the sale of the truck be moved into Highway. [5] May Boxler Flint Herman Ahl. Noes [0] Carried

The new truck should be here the 1st week in September, to the dealers. Also working on the shoulders on Syler Road.

Town Clerk Report: The Towns total revenue for the month of July 2023 was \$772.00, \$387.00 for dog licenses, \$40.00 for registrar, \$80.00 for marriage and \$60.00 for other. We had 27 renewal and 7 new licenses. To the general fund, \$460.00, \$205.00 for Zoning, \$120.00 Dogs, \$35.00 for late fees, \$40.00 for marriage license, \$40.00 for registrar, \$25.00 for fireworks permit. We disbursed \$215.00 to Wyoming County, \$52.00 to Ag and Markets for dogs and \$45.00 to NYSDOH.
