RESOLUTION NO: SL - 34 - 2018

TITLE: New 93-638 Contract Application with the Bureau of Indian Affairs for Higher Education Program for Fiscal Year 2019 - 2021.

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Governing body set forth in the Articles of Association approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is authorized under Public Law 93-638, to request the Bureau of Indian Affairs to enter into contracts for services and programs on behalf of their constituency; and

WHEREAS, the Summit Lake Paiute Council has prepared an application which includes Scope of Work and a budget, to submit to the Bureau of Indian Affairs for a Higher Education Program pursuant to P.L. 93-638; and

WHEREAS, the Summit Lake Paiute Council is requesting to enter into a multi-year contract with annual reporting requirements for three (3) years, and has specified the contract period as stated below:

- JANUARY 1, 2019 – DECEMBER 31, 2019
- JANUARY 1, 2020 – DECEMBER 31, 2020
- JANUARY 1, 2021 – DECEMBER 31, 2021

WHEREAS, the proposed date of this contract is from 1/1/2019 TO 12/31/2021.

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby approves the submittal of the multi-year Contract Application for a Higher Education Program; and

NOW BE IT FINALLY RESOLVED, that the Summit Lake Paiute Council authorizes the Tribal Chairperson, Vice Chairperson or Council Secretary-Treasurer to enter into, negotiate, or execute a new PL 93-638 contract, and any amendments thereto for the Higher Education Program from 1/1/2019 to 12/31/2021.
