Pro-Rata Receivables - FY2019

Treasurer Getty provided an update on the FY2019 Pro-rata receivables. All payments have been received, except for Districts 106, 204, 217 and LADSE.

Cook County Tax Distribution – FY2021

The decision by the Cook County Board to waiver of property tax late fees for up to 60 days after the due date passed in May as expected. The waiver is not expected to apply to mortgage companies or third-party payors but may have an impact member district cashflows. As a result, the TTO is planning for additional liquidity to assist member districts and discussing the possibility of developing a lending program for agencies within Lyons Township.

District 204 Litigation Update

Due to the Covid-19 pandemic the Circuit Court of Cook County has put a hold on all civil litigation proceedings. A new trial date has not yet been set. All filings are current and available on the TTO’s public website. The Trustees remain willing to participate in settlement discussions.



The Trustees discussed FY 2021 - LTTO Employee Compensation.



Trustee Dickman moved to adjourn the Closed Session, seconded by President Thiessen. Closed session was adjourned at 8:48 PM.


