Highlights of the "Minutes of the Meeting"

February 12 At tonight's meeting. Gold Star Post Vice-Commander Matthew Baldassano introduced current County Vice-Commander Frank LaMarsh to the membership. Frank is running for County Commander this June and has asked for our support. One of Frank's goals is to establish a Veterans cemetery on Staten Island. The closest Veterans cemetery is on Long Island, 75 miles away.

Ferdie Salvatore reported on the Mid-Winter conference held in Albany on January 29-31. (see article in newsletter).

Leo Milham reported that the Veterans Administration is considering closing down the Veterans Medical Clinic on Water Street in Stapleton. It seems that not enough veterans are utilizing this facility. We urge all veterans to visit this clinic and sign-up. If this clinic closes, the nearest facility is the VA hospital in Bay Ridge, Brooklyn. In addition, the VA is also considering to shut down the VA Regional Office on Houston Street in Manhattan.

In a few months the City of New York will begin building a new baseball stadium in St. George for our new Class A baseball team, the *Staten Island Yankees* of the New York-Penn League. Our Post, along with other Posts on Staten Island are requesting that the new stadium be named after Pvt. Joseph F. Merrill, Jr., Pvt. Merrill, a World War II veteran from Staten Island, was awarded the Congressional Medal of Honor, posthumously, for bravery above and beyond the call of duty.

The Post has accepted an invitation from the Travis 4th of July Committee to participate in this year's Fourth of July parade. Our contingent will consist of our Honor Guard and members from our Post and the Sons of the American Legion.

The Post also voted to make a donation of \$50.00 for a 1/2 page ad in the Korean War Veterans souvenir journal.

Post member William Castle was recently released from the hospital. We wish William a speedy recovery and hope to see him at Post meetings in the future.

Mid-Winter Conference

From Friday, January 29th, through Sunday, January 31th, the Eightieth Annual Mid-Winter Conference was held at the Desmond Americana Hotel in Albany. New York State Commander Robert L. Morrill outlined the American Legion's 1999 Legislative Program to the membership. This "program" was formulated and adopted by the legionnaires to bring immediate and long term benefits that the 1.7 million veterans of New York State are entitled to. This legislative program will be forwarded to the New York State Assembly, State Senate and the Honorable Governor of New York State, George E. Pataki for consideration:

Establishment of a VETERAN'S HEALTH CARE AUTHORITY. Construct a NYS VETERAN'S CEMETERY IN SENECA COUNTY. Amend the NYS REAL PROPERTY TAX LAW to include Lebanon/Grenada, Panama and Persian Gulf veterans. Provide a three year retirement credit for WARTIME SERVICE for members of the NYS retirement system. 'Exempt VETERANS ORGANIZATIONS from Fuel Tax. Amend the REAL PROPERTY TAX LAWS to allow Veteran's exemption of school taxes. Give a VETERAN'S WAR-TIME BONUS to veterans of the Vietnam, Lebanon/Grenada, Panama and Gulf wars.


