Announcements and updates...

- **2026 ANNUAL MEETING.** The 2026 Shiloh HOA annual meeting will be held on **FEB 10, 2026 (2nd Tue) at 6:00pm** in the Battle Creek Golf Course event center (building to the North of the golf clubhouse). **NOTE the earlier time**, this was recommended and voted on at the last annual meeting.
- **IMPORTANT! – BOARD ELECTION UPDATE**
In the recent FALL 2025 Newsletter, we reviewed the Bylaws and process governing the election of HOA Board members and Officers. And we also announced that Ron & Steve will not be candidates for re-election. Sadly, I must also announce that board member Doug Dejmaj will also not be running for re-election. At this point, unless we have additional volunteers or nominations, the 2026 HOA Board will likely be down to 4 members. Expect to receive a letter from the city with the meeting details sometime in the next few weeks.
