Introduction

Christine Kirchberg Jones of Nola|Van Peursem Architects introduced herself and Larrell Hughes and Justin Thompson of UAH.

Sign-In Sheet

All attendees were asked to sign in. A copy of the sign-in sheet is attached to these minutes.

Bid Date, Location and Procedures – include all properly executed forms for Accounting of Sales Tax and DBE participation. Subcontractor list is due within 24 hours of bid, and this requirement is for all bidders, not just the apparent low bidder. Contractors are not allowed to qualify bids as part of the bid or prior to the bid. Only bid documents and addenda are part of the contract documents. Submission of a bid is acceptance of the bid documents and all warranties implied within the documents.

Project Funding Source

The project will utilize local funding.

Tax Exempt Status

- Sales tax is NOT to be included in bid.
- The accounting of Sales Tax Form shall be included with the bid.

Contract Schedule

- Work may begin after a notice-to-proceed is issued by UAH. A notice to proceed is anticipated within 60 days.
- Substantial Completion date is noted as February 1, 2019. Refer to spec section 01 10 00.

Liquidated Damages

Noted in Appendix A – Supplementary Conditions of the Contract

Permit Requirements

- The contractor will be responsible for obtaining a permit from the Alabama Building Commission, and the fee schedule is included in the specifications. The permit fees shall be included in the bid.
- A City of Huntsville building permit is not required.

Contract Considerations

- DBE participation is expected and a 1.3% goal is requested. Refer to Supplement A to the Instructions to Bidders. Contractors shall include the required DBE forms with their bids, even if they cannot reach the anticipated goal.
- 30-day notice of cancellation is required by the UAH legal department on Contract Insurance forms. A template of the insurance wording will be provided to the low bidder.
- Employees are required to register with E-Verify.
- The general scope of work was reviewed as installing a roof hatch over the existing high-bay space, relocating utilities and equipment in order to install the hatch, and relocating a set of steps to an existing roof equipment platform.

Owner Comments

Larrell pointed out that the existing roof is still under warranty and modification to the roof must be coordinated to maintain that warranty. The existing warranty documents are included in the Project Manual for reference.
