We all depend upon the Amana Fire Department

It will be dine in or carry out. This delicious pasta supper will help support the ongoing effort to raise funds to build an addition to the Amana Fire Station in Middle Amana. The fire department is bursting at the seams with not enough space to house equipment and vehicles. With its tax funding stretched to the very limit, the volunteers and AFD Board of

The fund drive goal is \$800,000. That's the estimated amount needed to add onto the current structure to allow for more room to safely house the fire vehicles so that they can quickly leave the station in an emergency. Right now only 18 inches

The Amana Fire Department is supported by property tax dollars and receives just \$105,422 annually. That's the total amount received to train volunteers and maintain training certificates, maintain rescue vehicles and pay off the debt on the newest fire truck. This sum also pays for insurance on the vehicles and department, fuel for the trucks and equipment testing and certification. That leaves just small sum, just \$10,000, for new equipment including breathing apparatus and fire suits.






