Regular Meeting ----- August 9, 1990

The meeting was called to order by George White, ATTENDANCE
at 7:00 A.M. at the District office. Other Board members
present were David Maki, Bobbie Domenick, Karl Tangren, and
James Walker.

Special Service District members present were
George White and William D. McDougald.

Others present were Dale Pierson and Roberta High-
land.

George welcomed the two new members, Bobbie NEW MEMBERS
Domenick and Karl Tangren, to the Board.

Roberta read the minutes of July 26, 1990. After MINUTES
calling for additions or corrections to the minutes of the
meeting of July 26, 1990, and hearing none, the Chair
declared the minutes approved as read.

Dale reported the levels of the reservoir were RESERVOIR
holding steady, and if patterns of other years repeat, we STATUS
should have water through the season.

The truck has been in the shop to have the valves TRUCK REPAIRS
fixed, and they are getting the truck ready for registra-
tion.

Dale reported that Marcus Johnson has filed a Cer- MARCUS JOHNSON
tification of Readiness for Trial and our attorneys have
filed an objection.

Roberta explained she had put a notice in the TERMS OF
Times-Independent and San Juan paper noticing the terms of OFFICE
Jim Walker and John Groo are expiring in September.

Bill stated the meters are working on the wells at GOLF COURSE
the golf course, and Dale stated he had read them yesterday. WELLS

Karl asked if customers were within their 80% use. CUSTOMER USE
Dale stated the majority of the users were within the
parameters. Water use in general was discussed.

Dave Maki suggested we might consider additional LINE VALVES
inter-connections and valves on the system to make it easy
to valve off certain areas.

Dale reported the creek is down to 6 cfs in total WATER REPORT
flow. Jim reported that Moab Irrigation Co. is unhappy with
the water delivery and quoted the portion of the contract

dealing with wells and delivery. Jim also reported a portion of the MIC Board*are thinking of re-negotiating the contract. All of the District's wells are on and pumping to MIC. The contract was discussed. MIC wants more water delivered. Walker reported the readings showed present delivery is 7.3 cfs. What should be delivered is 9.25. The low reading gave them 4.41 cfs. The district was short 2.7 cfs yesterday. He suggested Pete Byrd's 2 wells, Carol Lee Clark's well, Downard's wells, and others could be utilized to deliver more water. Water use was discussed. Pierson reported Pete Byrd would not let us pump, the water is too brackish, Downard's well is too brackish, and Carol's well is not efficient. *membership

Dave Maki asked if Bob Byrnes was not doing what Mark Page told him to, and asked if Mark Page could not meet with the two Boards and settle these question once and for all. This is in reference to the time of day water is measured to the Moab Irrigation Co.*

George suggested the Boards meet with Mark Page again. Walker stated there is a ~~feeling on the MIC board~~* to break the contract in January. Walker thought that was not a good idea; he wants the District to be more supportive of MIC in their dealings with Page to have the readings taken as the MIC wants them. Conditions on the systems were discussed. Pierson pointed out the District had spent more than \$20,000.00 last year to pump water and had plans to improve the cemetery well. The well history of various wells were discussed. Walker then read from the contract the paragraphs concerning pumping from the Colorado River. Dave Maki asked Walker for a list of customers and their location so that he can make up a zone map of the MIC system. Additional wells were discussed. Pierson stated his understanding of the Board's feelings are to test for a well on Dan Holyoak's property and to go into the cemetery well to re-perforate, and try to upgrade the production. McDougald suggested that well might be re-drilled. *move of some Moab Irrigation members.

The bills were reviewed. Jim moved they be approved for payment. David seconded. MOTION PASSED.

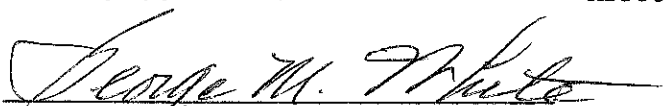
BILL APPROVAL
