**2019 USPHS IPEC Award Winner and Finalists Recognized for Interprofessional Collaborative Practice with Underserved Populations**  
*One national winner and four honorable mentions receive recognition for excellence in interprofessional education*

The U.S. Public Health Service (USPHS) and the Interprofessional Education Collaborative (IPEC) are pleased to announce Massachusetts General Hospital (MGH) Institute of Health Professions as the winner of the 2019 Public Health Excellence in Interprofessional Education Collaboration Award. USPHS and IPEC commend MGH and schools across the country working to promote, encourage, and support interprofessional education and collaborative practice to ensure the health of individuals and populations. The IPE in Excellence Award acknowledges interprofessional education learning activities and experiences designed to enhance interprofessional team practice and improve healthcare delivery.

“MGH’s profoundly positive and effective approach exemplifies how an innovative collaboration can scale up to promote community health,” notes Pamela M. Schweitzer, PharmD, BCACP, Rear Admiral (ret), U.S. Public Health Service. “These programs have changed lives and these changes will lead to improved efficiency and quality of care, with long-range outcomes addressing the social determinants of health and advancing health equity.”
