**VOTING BY ABSENTEE BALLOT**

**\*\*The elector must be registered in order to receive an absentee ballot\*\***

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day and who has resided in the ward or municipality where he or she wishes to vote for at least 28 consecutive days before the election. Proof of identification must be provided before an absentee ballot may be issued.

**You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.**

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the election. You may also submit a written request in the form of a letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot by mail, in person, E-mail or at MyVote.wi.gov. **Please do not wait until the deadline. Get your request in early to allow for the mail delivery.**

**Making application to receive an absentee ballot by mail:**

The deadline for making application to receive an absentee **by mail** is 5 p.m. on Thursday, April 2, 2026.

**Note:** Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

**Voting an absentee ballot in person:** You may also request and vote an absentee ballot in person in the clerk's office during the days and hours specified: **By appointment with the clerk during the hours of 10 a.m. to 4:30 p.m.: Monday—Friday and Weekends: By appointment.** The first day to vote in the clerk's office is Tuesday, March 24, 2026. The **last day** to vote an absentee ballot in the clerk's office: Sunday, April 5, 2026 by appointment.

**NO IN-PERSON ABSENTEE VOTING MAY OCCUR ON THE DAY BEFORE THE ELECTION.**

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on April 7, 2026. Any ballots received after the polls close will not be counted.
