### Tournament Rules

1. This tournament is open to 2022-23 USBC Youth bowling in certified youth leagues within the Appomattox River USBC.
2. This tournament shall consist of a Singles competition only. All bowlers will bowl 3 games.
3. The Highest **2021-2022** average from a USBC certified youth program will be used. If one does not exist then a current average as of **November 25** with a minimum of 12 games in an USBC Certified League. Coaches may send verification in after closing date. **Coaches must sign entry form to verify average.** Bowlers without a valid average may enter the tournament with an average of 200. All averages must be a USBC certified league average (Rule 319A).
4. Handicaps shall be based on 100% of the difference between the individual average and 200. Bowlers will be divided by Average into Divisions: Divisions may be adjusted based on the number of entries received per division.

5. Late bowlers will receive a zero for frames missed.
6. All fees must accompany entry form. EMAIL ENTRIES WILL NOT BE ACCEPTED UNTIL FEES ARE RECD.
7. Conduct derogatory to the best interest of youth bowling while competing in tournament play may result in possible suspension. See USBC Rule 17d.
8. Any appeal or protest regarding a decision of the score, tournament official, or tournament center must be made **in writing** to the Appomattox River USBC Youth Tournament Manager, no later than 72 hours after posting the final standings on the ARUSBC website (www.arusbcbowling.com). If no written protest is received prior to the 72 hour period, the decision will stand.
9. **SCHOLARSHIPS** will be awarded in all divisions to bowlers with an award ratio of **1 for every 6** entries received, per division. **An additional funds will be added to the Scholarship Fund from the ARUSBC Unassigned SMART Account. [ARUSBC SMART Acct #8620]** A minimum of first and second place will be awarded in each division.
10. All other decisions will be made by the Youth Committee and Tournament Manager.
11. Check in time will begin 30 minutes before shift. ALL BOWLERS MUST CHECK- IN WITH OFFICIAL.
12. **HATS, HEADPHONES, EAR BUDS, IPODS, MP3 type devices, and inappropriate T-Shirts are NOT ALLOWED.**
