The request for a transfer must be in writing or email and presented to the trial secretary or superintendent at least 30 minutes before the start of each trial. Transfers may be approved, provided the next level class and judge are available and the class has not reached its limit.

Transfers from an "A" to "B" class at the same level are allowed. The request for a transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial or anytime after close of entries. Transfers may be approved provided the class and judge are available, and the class has not reached its limit.
