### A Disappearing Ocean

Does the ocean make a sound if there is no one there to hear it?

I know that is a somewhat childish dip into the waters of phenomenology, but it begs a relevant question of modern anglers. Are we losing recreational fishing access to our nation's waters? It's a simple question. And if recent federal regulatory action is any indicator, I fear the answer becomes obvious.

In recent months, the U.S. National Parks Service disappointed anglers with plans to close 10,000-plus acres of prime reef fishing area in Biscayne National Park. There is increasing chatter about federal designation of marine monuments and reserves, marine protected areas and other tools designed to remove anglers from the environment by preventing them from accessing it.

Arguably, the most fundamental need of recreational angling is access. If you are prohibited from fishing, all of the complications of tide, wind, feeding patterns and every other nuance in successful angling become irrelevant. If you can't go fishing, it really doesn't matter if they're not biting.

The most popular recreational fishery in the U.S. is largemouth bass. You ask yourself why that is? Is it their sizzling runs? Their non-stop, Olympic-quality acrobatics? Fine table fare? I would argue that although they are an incredibly desirable sport fish to pursue, their unique and ubiquitous appeal largely comes from the fact that an eager angler of any age is rarely more than a short drive, bike ride or even walk from a pond, lake, reservoir or river that houses one of these fine fish. It is access that helps them be the target of hundreds of thousands if not millions of angler trips a year.

The lovable finfish species of our oceans and bays will always have a distinct disadvantage in luring prospective suitors, garnering a fraction of the angler trips per year that freshwater species do. By proximity, saltwater is quite a bit more difficult and often expensive to access. Although favorable improvements in so many forms of transportation have aided the ease in accessing coastal destinations, it is always going to be easier for a landlocked angler to access a largemouth over a saltwater species.

So why would the National Parks Service try to limit recreational angling in a marine-centered national park? Why would there be near-constant rumblings of potential massive marine nofishing zones being created via the Antiquities Act at the end of virtually every Presidential term in

the past two decades? I apparently missed when it was determined that recreational angling was such an imminent and imposing threat to the future of our nation's fisheries and the integrity of federal parks that it needed to be banned. I find it incredible that so much energy is put into efforts to remove recreational anglers from the marine environment when longlines, trawls and gill nets are not only allowed, but encouraged to clear-cut so much of our nation's coastal waters.

The above scenario is even more outrageous when you look at the economics involved. Recently, NOAA Fisheries announced in its annual report on Fisheries Economics of the U.S. that commercial fishing generated \$5.4 billion in revenue in 2014, but there was absolutely no mention in that same report of the amount of money that recreational fishing generated. If you look back at 2011, the last time NOAA produced recreational expenditure estimates, recreational fisheries generated \$23.4 billion in a single year! If you extend those estimates to the 2014 effort estimates presented in the current press release, recreational fishing generated \$24.4 billion in 2014.

Incredibly, that \$24.4 billion is generated on a mere two-percent of the nation's harvest of marine finfish. The commercial sector generates its \$5.4 billion on the other 98 percent, or 9.5 billion pounds of dead fish. And yet, the federal fisheries management system is regularly trying to promote and perpetuate commercial fisheries by creating privatized harvest rights and subsidies.

Are our shared oceans disappearing? They are not. But if access is denied to anglers through no-fishing zones or woefully misguided management regimes, the answer is inevitably a resounding Yes.

What I have long referred to as GOAL ORIENTED SCIENCE" IS A DECADES OLD PHENOMENON. <u>True "Science"</u> in the past, has always compiled all relative data concerning a particular study. They then digested and assimilated all that data, and reported their findings. "GOAL ORIENTED SCIENCE", Largely practiced today by <u>radical environmentalists</u>, may indeed in some cases actually compile all related evidence and data. They however no longer consider data, that does not support or promote, their preconceived hypothesis or agenda, as appropriate to be used in their finalized report. We are therefore provided with a false and totally irrelevant and biased study, which actually has no scientific value other than to promote the radical agenda of the progressive left environmentalists. We must also remain aware of the greens relentless pursuit of their agenda, understanding, they have infinite patience, survive with incremental ism, and seemingly have limitless financial resources. If we fail to challenge them in every manner available, we will surely lose our right to utilize our natural resources and our ability to fish......dick

Keeping an eye on the weather and the Pacific Dawns schedule, there was an opportunity early December so I booked a trip, got my gear ready and was set to go. Got a call the next day, trips cancelled due to lack of people, rats. Ok, there's one more trip in a couple of days so I book that one. Get a call again, this time the weather so bad it the boat won't be going out. This is serious here, will I get a chance to go out being close to the holidays? The weather settles down in several days, and a high develops, this is Dec. 17th. The boats' going out, I'm ready again. At the landing office I check in, my # is 10, lucky number. I was born on 10-10- 55. Only 16 anglers on board, nice lite load, plenty of elbow room. Fishing by San Miguel Is. the ling start to bite down very deep. My first hook-up is very heavy. As I see deep color I call for gaff, maybe two or three, it's pretty big. Just kidding, one will do. The ling weighs in a little over 19 pounds, wow! Turns out to be the J.P. this trip. Lucky #10. The boat loads up on the rockfish as the day ends, and a smooth ride back to port. Oh yeah I don't want to forget, caught the bad boy(female) on my famous rock cod bomb,true to form. One more trip maybe, Dec. 31st. last try at the surf. I go to the warm

water channel at Seal Beach where I fished growing up as kid on the rocks. No luck in two hours so I go home, stop by Turners in Norwalk, buy 2016 license, I'm ready

# December 27<sup>th</sup> on the Amigo By Luke Fitzpatrick

After having not fished since the week before Thanksgiving I was really looking forward to just being on the water. I got to the landing early and met up with Jeff Cribben of Cribbs Jigs, Andres Perez and Capt. Bill Cavanaugh for some pizza and laughs. After stuffing ourselves with pizza we made our way back to the landing and loaded everything on the boat and got settled in for a cold night headed out to San Miguel.

4:30am came quickly but most of us were awake already and ready to catchsomething. It want until my second cup of coffee that I realized sunrise wasn't until around 7:30, so we spent the couple hours laughing and telling fish stories.

Finally the sun came up and from our first drop we knew it would be a good day. The few of us that dropped jigs were immediately bit, and it stayed that way for the next couple hours. Over and over again our jigs got bit by large 6-8lb reds and chucks with a few short lingcod thrown in just to tease us. It was one of those rare trips where the baited hooks weren't getting bit nearly as well as our jigs and the fish that were eating bait were half the size

At around 11:30am Bill hollered at us to reel up, that we were going to go a couple miles away to try and get some bigger lingcod and that we would finish up our rockfish in the shallows. This would normally be where I tied on a 8-9" swimbait but I did something different and I grabbed an orange/red/brown/black 8oz jig the my friend made for wahoo and I stuck a 6" scampi on the 8/0 Owner siwash hook he had put on.

Finally, the boat stopped. Swimbaits and jigs went flying out and as soon as I hit bottom I was bit. It was either tail hooked or it was a very nice fish, either way I'll never know because half way up it popped free and I was left crying on the rail. I regained composure quickly and I dropped my jig back down.

BAM! I was bit again. This time I landed the fish but instead of being the 10-15lb fish that everybody else was landing it was about 8 inches and looked like it should be in an aquarium.

Finally, it was time to get set up again for another drift and this time I was going to be ready. The boat circled around and I heard the engines slow down. I lobbed my jig out and let it sink.... and sink.... and sink! Finally, I hit bottom again and this time rather than bounce the jig I yoyo'ed it and didn't make it 6' off the bottom before I was bit. This time my 9' Calstar 690J stayed bent as the fish held its ground and didn't want to come up.

I set the rod on the rail and slow cranked the fish up to the surface. It dogged me the entire way and tried to pull me around but it never tried to head back to the bottom so when I got it to the surface I didn't think it was nearly as big as it was.

I yelled for a gaff and Shane was on it! The fish was gaffed and as it came over the rail it was clear that this fish was my biggest lingcod and would probably be a jackpot fish.

Shortly after we moved into the shallows and fished light tackle for some amazing quality rockfish and ended the trip with limits of rockfish and lingcod, 15 sheepshead and 1 rocksole for 20 people.

On our way in we took some pictures and got the weights of our lingcod. Just as we thought, mine was the biggest at 20lbs and then we had another 30+ that were 14-15lbs.

All in all it was a phenomenal way to end what might be the best fishing year in SoCal history!
