- 2. MCL Forms, as National updates our official forms they post them to the National website Library. Please visit the Library and download the form each time you need to submit paperwork to ensure you have the most current form and instructions.
- 3. 2019-2020 membership fees are due by August 1st. Let your members know that you are starting to collect and submitting now so there is not a heavy work load placed on your Paymaster this summer to submit transmittals and checks all at one time.
- 4. Detachment Officer elections make sure you send Department Adj/Paymaster Harvey Harris your signed ROI form the day after the installation event. All information must be filled in completely & legible. DO NOT assume National will just pick up information from last year. All addresses must be member's home address not a business address, same as individual membership address.

Greetings all, spring has finally arrived. Paymasters it is now time for the detachment's required annual tasks to be completed that are due between now and July, that being detachment's 990's, renewing the not-for profit registration with the Sec. of state, ROI for your detachment, Life member Audits take place following the June roster, after you receive the June roster you may as well verify and send in your 2019 Life Member Audit report to make sure you receive your refund for Life members. Remember if you do not submit your audit you will not receive a refund from national. Renewal for all non-life members can be completed anytime now through August 31. If a member is current the renewal will be credited for next year so you will not have to collect all memberships in a single month. Renewal Schedule: MCL A&P Section 7025 (d) All non-life memberships expire August 31 of each year. New members joining between 1 July and the last day of February will pay the full amount of the National Dues + \$5.00 Initiation fee, new members joining between March 1 and 30 June will pay ½ half the current National Dues + **Initiation fee of \$5.00.** A change from National: The ONLY paper form required to be submitted to department is the Transmittal, (a check needs to be sent to department and national with the required dues). One page only, no longer required to submit multiple pages. All other reports may be submitted by electronic means. (scan into your system and sent department a copy, department will forward a copy electronically to national).

The department roster was sent out to all Detachment Commandant's and Paymaster mid-April, please check your roster and verify the accuracy of the roster as the information is now being down loaded into the new database at national. Report to the Department Paymaster any errors or omissions discovered, and we will get them corrected. Please include the member's email address, this will cut down on the mailing expenses.
