CAASA Report : Supervisor Thelen reported that at their monthly meeting the by-laws are being revised, just to keep them up to date. All ambulances are in good working condition, ambulance runs were down this month and the Community Paramedic program is still in the process of getting established, but much needed monies are needed for funding.

Correspondence: A Thank-you was read from the owners of the Eureka General store for the well wishes from the Township on their new adventure and leaving our Township.. The Township is still getting ongoing notification of drain and ditch work that will take place in various locations.

Public Comment: Residents Graham and Owen conveyed to the Board their concerns of what is going on with the Planning Commission and the Clinton County Commissioners.
