



# Insurance Company and County Farm Mutual Appointments and Terminations

## Company Appointment Renewals

All company appointments and terminations for insurance companies and county farm mutual companies are required to be processed electronically through the National Insurance Producer Registry (NIPR). Electronic processing is mandatory pursuant to North Carolina General Statute (NCGS) 58-2-250
