The Governing Body of the City of Garnett met in regular session on August 14, 2018 at 6:00 p.m. at City Hall with the following present: Greg A. Gwin, Mayor Pro-Tempore; Brigitte Brecheisen-Huss, City Commissioner; Chris Weiner, City Manager; and Terry J. Solander, City Attorney. Also attending: Nancy Hermreck, Interim City Clerk. Absent: Jody M. Cole, Mayor; and Will Mechnig, ACHS Youth in Government Representative.

CALL TO ORDER

Mayor Pro-Tempore Gwin called the meeting to order at 6:00 p.m.

The Pledge of Allegiance was recited, followed by Vernon Yoder, Mont Ida Church of the Brethren, giving the invocation.

APPROVAL OF MINUTES

The Governing Body reviewed the July 24, 2018 minutes of the City Commission Meeting. After corrections, Mayor Pro-Tempore Gwin made a motion to approve the July 24, 2018 City Commission Meeting minutes as amended. Commissioner Brecheisen-Huss seconded the motion. On roll call, the following vote was recorded: Ayes – two; Noes – none.

PUBLIC FORUM

Ty Hedrick of Boy Scout Troop 126 made a presentation on his Eagle Scout Service Project. He built a bridge across hole 7 on the Disc Golf Course located at Lake Garnett.

GOVERNING BODY

Mayor Pro-Tempore Gwin let everyone know that Friday night is the Anderson County Fair Tractor Pull and on Sunday, the first sanctioned sprint race in many years will be held at the sprint track. Mayor Pro-Tempore Gwin asked for an update on the street pavement project. City Manager Weiner informed the commission that Bettis Asphalt agreed to lower the price of asphalt to \$80 per ton. They also agreed to lower the cost even further to \$79 per ton, if the city uses above the estimated quantity of asphalt that was bid.

Commissioner Brecheisen-Huss thanked the people who provided beneficial services and activities to our community this summer. In particular, she thanked the lifeguards for teaching swimming lessons and protecting our children on a daily basis; our parks and recreation departments for coordinating all the summer sports activities; the library for the work they put into the Rock Summer Reading Program; our local ECKAN representatives Brandi and Jennifer for working the free lunch program, as well as, all the churches who volunteered to help serve the children. The people who dedicate their time to participate in our community band; the volunteers at the Anderson County Historical Society for all of their work at our museum. And for all of the individuals involved in coordinating and submitting entries to the Anderson County Fair. There are so many groups and business that Commissioner Brecheisen-Huss didn't mention that she would like to thank for making our town feel more like a home. Commissioner Brecheisen-Huss also congratulated Julie Turnipseed for being the new Economic Development Director.

CITIZENS TO BE HEARD




