## Rules

- Futurity Horses – Must be 5 years old or younger as of Jan. 1<sup>st</sup>, 2017. Futurity Horses may have never competed for money, prizes or points at any time prior to Dec. 1<sup>st</sup>, 2016. Futurity Horses have one (1) year of eligibility. Horses that are not registered with an association must have certification from a veterinarian on the horse's age.
- Futurity is a 2D full second split.
- Futurity horses must be checked in with their papers and numbered during scheduled times.
- We will be paying out an average in the futurity only.

- \$50.00 Horse/Rider substitution for the Futurity after March 15<sup>th</sup> deadline.
- Buy outs are allowed but must be handled through the Salty Dash.
- All Contestants must complete the entry forms and sign waivers before running.
- Western Attire is required for both the open and futurity. (Long Sleeved Shirts, pants, boots, cowboy hat or helmet.
- Vet/Doctor Releases must be provided to receive a refund (80% will be refunded after March 1, 2017) for Open Entries Only.
- No refunds will be given once the race starts for that day.
- Contestants must be present to receive awards. If you are not present, we will not be giving awards to representatives due to past issues.
- Contestant will receive a no time for knocked over barrels or broken patterns in the Open.
- Once draw is posted, contestants must run in that order. Any horse substitutions, the office must be notified prior to the run, or the horse/rider combination will be disqualified.
- Three gate calls will be given for each contestant before turn out.
- All Dogs must be on leashes at all times. This does include the arena and the barn area.
- Returned Check Fee \$25.00
- Animal Abuse will not be tolerated and could result in a disqualification. This will include all horses rider is entered on. This will also include any associates of the rider.

By signing this document, I agree that I am aware of and will abide by the Rules and Regulations of the Utah Horse Council, Inc.

In addition, I hereby waive any all claims which may arise between myself and the Utah Horse Council, Inc. [hereinafter "UTHC"] or between myself and third parties (i.e. Davis County, Salt Lake County, Weber County, Tooele County, Utah County, Herriman City, Wasatch County, West Jordan City, the Board of Directors and the agents, members, servants and employees) as a direct or indirect result of my participation in any UTHC event. Should anyone or any legal entity bring such a claim, I agree to indemnify the UTHC. My waiver does not include any claim I may have against the UTHC for monies won as a result of my competitive performance at a UTHC event.

By signing this document, I agree that I have been informed of the Utah Equine Activities Law (U.C.A. §§ 78B-4-201 et seq.) and that there are certain risks inherent to my participation in an equine or livestock activity. I acknowledged that those inherent risks include dangers or conditions which are an integral part of equine or livestock activities, and may include the following:

- (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them;
- (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals;
- (c) collisions with other animals or objects; or
- (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.

Furthermore, I acknowledge that I am a "Participant" in an equine or livestock activity as defined by Utah Code Ann. §78B-4-201 and that my status as a participant will continue through the duration of the entire event (i.e. even subsequent to my competitive turn).
