501(c)3: FOR THE PUBLIC, donations charitable in nature, services must be open to all, No part of net earnings may inure the benefit of any private shareholder or individual. Donations must be used for public benefit and can not be given to 501(c)4. We can list them as a sponsor, but not promote their individual activities

501(c)4: Promoting the area. Services may be provided to members only if they benefit the entire community. No part of net earnings may inure to the benefit of any private shareholder or individual. Can give to a 501(c)3.

Clarification: Sponsorship listing is fine from 501(c)3, but the moment we say "Go buy..." it becomes advertising which should come from 501(c)4

Unrelated business income must pay taxes on advertising dollars and file 990T
