Online Sales Option: If selected, a code will be provided for online sales. Customers pay \$5.95 for shipping and pay sales tax.

Samples, Late Orders: No product minimum required. Regular pricing applies for samples and late orders.

State Sales Tax: State Sales Tax is paid by Fit & Fresh. Tax will not be added onto your invoice.

Shipping: Shipping is free on all orders except online sales if selected.

Payments: Customer checks are made payable to your organization. A single payment by Money Order, Business, or School Check will be accepted for your purchase. Personal checks, temporary checks, checks with hand-written group/business names can't be accepted. Credit cards are not accepted. Payment must be paid in full prior to the order being shipped.

Pack-By-Seller: Provided Free. Organizations will receive a postage-paid envelope for returning their order forms.

Delivery: Products are generally delivered within 3 weeks from date organization mails completed order forms to Fit & Fresh.

Missing Items: Replacements for missing or damaged items will be shipped upon completion of a discrepancy form provided by Fit & Fresh.
