Tizzy Takeover and Mmm'adness brochures: An order can be accepted with 300 items but there will be a 79 cents fee for each item short of reaching the 396 minimum item required. For small organizations we recommend selecting brochures #1-#4 which only require 120 items.

Brochure Fee: Brochures are FREE! There are NO upfront costs for your organization.

Bulk Order / FREE Pack by Seller: Bulk orders require a minimum of 120 items and are ordered by cases of 6 items each. FREE Pack-by-seller orders require a minimum of 396 items and do not require cases. Orders with 300-395 items can be packed-by-seller for 69 cents per item.

Profit: Percentage of profit is determined upon the number of items sold. Organizations can earn 25-55% profit. 120 items – 25%, 204 items – 30%, 300 items – 35%, 396 items – 40%, 792 items – 45%, 1650 items – 50%, 4000 items – 55%. Organizations are invoiced for only the actual amount due. Profit is retained by the organization. Orders less than 120 items or late orders will add shipping and processing fees.

Product Availability/Pricing Guarantee: Brochures retire 06/30/16.

Tax: No State Tax is collected.

Shipping: Shipping is free with 120 items sold for brochures #1 - #4, free with 396 items sold for brochures #5 - #6. Orders are shipped Common Carrier, require a signature and must be shipped to a school, business, or commercial address. In a few very remote areas an additional fee will be added but if there is a fee you will be notified before starting your fundraiser.

Payments: Customer checks are made payable to your organization. A single payment by Money Order, Business, or School Check will be accepted for your purchase. **Personal checks, temporary checks, checks with hand-written group/business names** can't be accepted. **Credit cards are not accepted nor are school purchase orders.** Payments by check/money orders must be paid in full prior to the order being processed. Returned checks will be charged \$50.00.

Delivery: Products are generally delivered within 2 weeks for bulk orders, 3 weeks with pack-by-seller orders.

Check-In Forms: Replacements for missing or broken items will be shipped only when a fully completed Check-In Form has been submitted within **2 business days only**. **Phone calls or emails requesting replacements without a Check-In Form WILL NOT be accepted. No exceptions.** Organization will be responsible for the accuracy of the total number of items sold and ordered.

Sales Agreement: MUST be returned to Deb Murray prior to distributing your brochures. I have read, understand and agree with the terms and conditions listed above and have received approval from my organization (school principal, board members etc.) to sign on behalf of my organization.
