**2021-2022 Schedule of Live Seminars.** Our entire year's schedule is posted at our website (<u>www.opticalseminars.com</u>). Hope to see you at a live event. In the "smaller" cities, the way it works is we do one seminar each year – with no repeats from the year before. So, for example, if you attend this year in Sarasota, and then again next year in Sarasota, you will have all the necessary hours you need to renew your license. Attend a weekend seminar in Tampa, Ft. Lauderdale, or Orlando and you'll have all necessary hours.

**Initial Hours for Licensure.** There are two courses that are needed for people getting their licenses for the first time: Initial Laws and Rules, and the Hands-On Adjustment Class. Apprentices are also required to take an Apprentice Orientation course in the first year of their apprenticeship. Optical Seminars offers these classes on-demand! For the Initial Laws and Rules and the Apprentice Orientation course, you may take them as home-study courses and do them immediately, on-demand. The Hands-On Adjustment class is offered at all live events. The price for these courses is \$20 each. We also offer a live, one-on-one version of the Hands-On Adjustment class by appointment in Hudson, Florida. The price for that session is \$40. **Home-Study Courses.** As most of you know, we are normally restricted to a maximum of five out-of-classroom hours for our continuing education. Due to COVID-19, in March I requested that the Board waive this limit so that all who felt it necessary to take hours at home could take all of them out-of-classroom for this one biennium. Without going into details or harping on the

disappointment I had with the position that some Board members took, finally on July 24th it was decided to allow that all hours could be out of classroom for this one biennium.

Remember, you may not repeat any continuing education class in the same biennium. However, you MAY repeat a continuing education class that you took in a previous biennium. What that means is that you may retake a course and resubmit answers for an out-of-classroom course you took in 2020 right now. These hours would then be applied to your renewal in December 2022. Of course, right now you are limited to five hours out of classroom for this renewal period.

**New Classroom Courses.** As of January 2021, we have more than 220 unique continuing education hours available! While I cannot say for sure, I think that is more than any other Florida education provider offers. Still, we are always trying to add new courses and whenever possible, new speakers. For this biennium, while I will be teaching most of the classes myself, I am proud that we will also have classes presented by Dr. Linda Paey, Karen Hunt, and John Zimmerman.
