### NOTICE: SAME ADDRESS, CHANGE OF LOCATION

These Trials have been moved from the previous site, the Judging Arena, to a different location, roughly 250 feet to the east, named "The Pavilion." The new site is described as "Outdoors, under cover"; however, the perimeter of the building is enclosed fully on three sides and partially on the entrance side by white translucent tenting material as protection against wind and inclement conditions. The site measures 220 feet by 100 feet. In the center of the building is an area 200 feet by 60 feet with artificial turf enclosed by a low wall with gates at intervals for entrance and exit. The rings will be in the turfed area and will not be matted. There is ample parking on three sides of the building.

There are no restrooms in The Pavilion. Porta-potties will be located at the front of the building and hand sanitizer will be readily available.

**THE PAVILION HAS EVAPORATIVE COOLING, WHICH WILL BE TURNED ON IF REQUIRED.**

**ENTRY FEES WILL NOT BE REFUNDED** in the event of (1) errors or cancellation of entries after the published closing date, (2) the dog being absent, (3) the dog being disqualified, excused by Veterinarian or Judge, or barred from competition by the Trial Committee, (4) having been entered incorrectly. **A refund will be provided if a bitch comes into season. Please inform the Trial Secretary as early as possible if your bitch has come into season and you would like a refund.**

RETURNED CHECKS do not constitute a valid entry fee. The Rio Grande Obedience Dog Club, Inc. will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in his or her being put on a CASH ONLY basis.

NO ENTRY FEES will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the Club.

A RECORDING FEE OF \$.50 will be required for each dog entered at any show held under the rules of the American Kennel Club. The AKC will also collect a \$3 Event Service Fee for the first entry of a dog and a \$3 service fee for each additional entry of the same dog in each show.

ALL ENTRIES are to be mailed with Fees to the Trial Secretary, John Dick, 304 Purple Hills Way, El Paso, TX 79912. Entries will not be accepted without fees. Acknowledgment of entries will be made as soon as practicable. Should such acknowledgment not be received by the exhibitor within a reasonable time please contact the Trial Secretary.

DOGS MUST BE READY FOR JUDGING. The club and its committees will not be responsible for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of the dogs in the ring. Dogs need to be at the trial only at scheduled time of judging and may leave immediately thereafter unless required for further judging.

THE CLUB RESERVES THE RIGHT TO SUBSTITUTE a prize of equal or greater value. All trophies must be claimed the day of the trial. None will be mailed.

**EXHIBITORS ARE ADVISED TO BRING THEIR DOG'S LICENSE TAGS AND PROOF OF RABIES VACCINATION WITH THEM TO BE IN COMPLIANCE WITH EL PASO CITY ORDINANCES.**

There should be abundant space for crating. THE CLUB may request that crates be placed in specific areas. No roping off or reserving of crating area by any method is permitted.

ALL DOGS MUST be kept on leash when not crated or in exercise pens or in the ring.

EXHIBITORS are expected to keep crating and exercising areas clean.

ANY AND ALL DAMAGE caused by the exhibitor will be the sole responsibility of the exhibitor. Parents or guardians will be totally responsible for the actions and safety of their children.

TRANSFERS (Both Rally and Obedience) ARE ALLOWED: a transfer (i.e., from an obedience class to an obedience class or from a rally class to a rally class) may be requested if, according to the owner's records, the handler and dog are eligible. The request for a transfer must be made in writing to the Trial Secretary at least 30 minutes prior to the start of each trial; **requests submitted prior to the date of the trial will be accepted.** Transfers from "A" to "B" class at the same level are allowed. Transfers will be approved provided the class is scheduled and the judge is available.
