Ordinance O-2017-09

**AN ORDINANCE REPEALING AND REPLACING CHAPTER 112 OF THE
AMELIA CODE OF ORDINANCES RELATED TO PEDDLERS AND SOLICITORS
AND DECLARING AN EMERGENCY**

WHEREAS, the Amelia Village Council seeks to repeal Chapter 112 of the Amelia Code of Ordinances and replace it with new regulations that address recent changes in the law governing the ability of the Village to regulate peddlers and solicitors.

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

SECTION 1: The Amelia Code of Ordinances Chapter 112 shall be repealed in its entirety and replaced with the attached Chapter 112 regulating peddlers and solicitors in the Village.

SECTION 2: That this Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is declared to be an emergency measure necessary for the preservation of the health, safety and well-being of the residents of the Village in order to ensure continuity and immediately begin regulation of peddlers and solicitors in the Village.

SECTION 4: This Ordinance shall take effect at the earliest period allowed by law.

Mr. Campbell moved to suspend the rules requiring three readings on three separate dates.
