## Discussion

**Horse Chestnut,** the common name for aesculus hippocastanum, is a promising natural medicine for treating chronic venous insufficiency. It is an anti-inflammatory herb that has been found to promote normal tone of the vein wall, thereby improving circulation through the veins. Benefits can include reduced leakage of the capillaries and a reduction in lower leg swelling.\*

**Gotu kola**, also called centella asiatica, is a trailing plant native to Asia. Its many uses include the treatment of venous insufficiency and the healing of wounds. Gotu kola stimulates the production of collagen, a protein found in the fibrous tissue of blood vessels. Studies have reported its effectiveness in healing vein walls and tissues. Its benefits include reduced swelling and improved circulation and vascular tone.

**Butcher's broom extract** is the common name for ruscus aculeatus, a berry-producing evergreen shrub found in the Mediterranean has significant toning effect on veins that eases the sensation of tired, heavy legs.

**Citrus Bioflavonoid** are phytonutrients with strong anti-inflammatory effects, which include strengthening capillaries. Furthermore, they enhance the effects of vitamin C (vitamin C is known to support blood vessels) and support blood circulation, which results in reduced swelling, venous backup, and edema.
