### Food Booth Rules & Regulations

**September 14, 2019**

The Mexican Heritage Society of Port Arthur will provide 1 Booth, 8x10 with three tables, backs open for access, in the Port Arthur Civic Center. Food Booth Vendors have the options of providing Authentic Mexican Foods, Curios and Souvenirs.

Booth Reservations must be made through the Fiesta Booth Chairman/ Committee. All applicants are subject to consideration and approval by the Executive Board. All applicants will be considered with preference as follows:

1. Local area churches.
2. Local organizations that work or help disadvantage and/ or handicap individuals of Mexican American descent.
3. Interested individuals or groups of Mexican- American heritage.
4. Interested local Mexican Restaurants.

Charge for **Rental of one booth is \$250.00.** The Mexican Heritage Society sets Booth fees.

Deadline to reserve food booth is August 20<sup>th</sup> of the current year. If reservation is not reserved by the due date, the Mexican Heritage society will have the option to assign the booth to the next applicant on the waiting list.

Fiesta will be on September 14, 2019. Time is tentatively set from 8:00 a.m. till Midnight. You may set up as soon as 8:00 am on Fiesta Day.

Booths will be erected at the Port Arthur Civic Center the evening prior to Fiesta.

Each booth will have a total of 30 amps available (2 double receptacles).

#### **NO BUTANE OR MICROWAVE PERMITTED**

Each booth must have a sign visible to the public with the name of the operator, or name of the organization, sponsor, etc.

Each booth **MUST have a food permit** issued from the City of Port Arthur Health Department.

Each booth must be attractively decorated.
