## MINUTES OF THE CLOSED MEETING OF THE LYONS TOWNSHIP TRUSTEES OF SCHOOLS April 25, 2016

#### 1. Call to Order.

The Closed Session of the Lyons Township Trustees of Schools was called to order by President Michael Thiessen at the Township School Treasurer's Office, 22 Calendar Court, LaGrange, Illinois at 6:12 p.m.

#### 2. Roll Call.

Taken by President Thiessen. Present were President Thiessen, Trustee Tobolski, Trustee Dickman, Treasurer Susan Birkenmaier, attorney Kurt S. Asprooth.

3. Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when a public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 120/2(c)(5).

President Thiessen discussed his frustration with the litigation and the delays from School District 204 in providing mediator names and engaging in settlement discussions. President Thiessen discussed issuing a statement to the school districts explaining the current status of the litigation and the reason for the delay in reaching a settlement. The Board agreed with President Thiessen that a statement should be issued. The Board then discussed potential settlement options with School District 204 and whether the school districts would support a settlement with School District 204. The Board then discussed whether School District 204's legal costs are being covered by insurance or not.

4. Discussion of the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body. 5 ILCS 120/2(c)(5).

Treasurer Birkenmaier discussed her recommendation for the junior accountant position of Maurice Brown. The Board then discussed salary recommendations for the position, and the long-term goals of the Applicant. The Board asked that Tresurer Birkenmaier confirm the Applicant's references, but otherwise was supportive of the hire.

Treasurer Birkenmaier then discussed her recommendation for the senior accountant position, Rob Pritts. The applicant is a CPA and has experience working with the school districts served by the Lyons TTO. Treasurer Birkenmaier stated her belief that the Applicant will provide substantial benefit to the office given his experience and depth of knowledge. The Board then discussed the Applicant's experience and reasons for leaving his current position. The Board was supportive of the Treasurer's recommendation, but

President Thiessen first asked to schedule a time to meet with the Applicant. The Board then had additional discussions regarding the Applicant's past experience and achievements.

Treasurer Birkenmaier then discussed the distribution of work to specific employees and what duties each employee may be able to take on given the three employees who will be retiring.

The Board then discussed the terms and impact of the separation agreements that will be signed by the three employees who are retiring.

5. Litigation, when an action against, affecting or on behalf of the particular public body has been filed and is pending before a court or administrative tribunal, or when a public body finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the minutes of the closed meeting. 5 ILCS 120/2(c)(5).

The Board then held an additional discussion on the settlement options for the School District 204 lawsuit and the likelihood of whether any potential settlement will involve School District 204 being removed from the Lyons TTO.

7. Discussion of the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the public body. 5 ILCS 120/2(c)(5).

Treasurer Birkenmaier then discussed her recommendations for compensation for specific employees for the upcoming fiscal year. The Board then discussed each of Treasurer Birkenmaier's recommendations for the employees. The Board decided to wait to take action on the updated salaries until the next board meeting.

The Board then discussed the motions and potential action that the Board would take on the hiring recommendations of Treasurer Birkenmaier.

The Board then discussed potential candidates for the receptionist position.

#### 8. Adjournment.

Trustee Tobolski moved to adjourn the Closed Session, seconded by Trustee Dickman. A roll call vote was taken, with President Thiessen, Trustee Tobolski, and Trustee Dickman voting aye. Closed session was adjourned at 7:16 p.m.
