

AN ORDINANCE CALLING AND PROVIDING FOR THE HOLDING OF AN ELECTION WITHIN AND FOR THE VILLAGE OF INNSBROOK, WARREN COUNTY, MISSOURI TO BE HELD ON TUESDAY, THE 3 DAY OF NOVEMBER, 1998, FOR THE PURPOSE OF SUBMITTING TO AND TESTING THE SENSE OF THE QUALIFIED VOTERS OF THE VILLAGE OF INNSBROOK, MISSOURI ON THE QUESTION OF INCREASING THE TAX RATE OF INNSBROOK, MISSOURI IN COMPLIANCE WITH STATE LAW, DESIGNATING THE TIME FOR THE HOLDING OF SAID ELECTION AND THE PLACES IN WHICH IT SHALL BE HELD, APPOINTING THE JUDGES TO CONDUCT THE SAID ELECTION, PRESCRIBING THE FORM OF BALLOT TO BE USED THEREAT, SETING OUT THE FORM OF NOTICE OF SAID ELECTION, AND DIRECTING ITS PUBLICATION

WHEREAS, the Board of Trustees of the Village of Innsbrook, Warren County, Missouri deems it necessary and advisable to provide funds to meet the cost of municipal services, and

WHEREAS, the said Board of Trustees finds that there are not sufficient funds available in the ~~City~~ <sup>Village</sup> Treasury to provide the level of services desired by the citizens of Innsbrook, Missouri, and

WHEREAS, Article X, Section 22 of the Constitution of the State of Missouri, requires that voters must approve any increase in taxes, license, and fees:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF INNSBROOK, MISSOURI AS FOLLOWS:

Section 1. That at the next election to be held in the Village of Innsbrook, Missouri on Tuesday, the 3 day of November, 1998, for the purpose of submitting to and testing the sense of the qualified voters of said Village upon the following proposition:

Proposition Number One: To establish and increase the tax levy of the Village of Innsbrook, Missouri in the amount of FIFTEEN cents on the one hundred dollars valuation.

Section 2. That the polling places for said election shall be and are hereby designated as follows:

*Interim Village Hall,  
1835 Highway F  
(Designated Polling Places)  
Innsbrook, MO 63390*

Section 3. That the following named persons be and the same are hereby designated as Judges of said election:

WARREN County Election OFFICIAL AND her deputie  
(Designated Judge of Election)

Said election shall be conducted in the form and in the manner provided by law.

Section 4. That the Board of Trustees be and they are hereby authorized and directed to cause to be published in the MARTHASVILLE RECORD a ~~(daily or weekly)~~ newspaper published in the Village of Innsbrook, Missouri, notice of said election, which notice shall be in substantially the following form, to-wit:

#### NOTICE OF ELECTION

Pursuant to an ordinance adopted by the Board of Trustees of the Village of Innsbrook, Missouri, and approved by the Chairman of the Village of Innsbrook on the 23 day of July, 1998, for the purpose of testing the sense of the qualified voters of the said Village on the following proposition:

#### PROPOSITION NUMBER ONE

Shall there be an increase to the tax levy of the Village of Innsbrook, Missouri in the amount of Fifteen cents on the hundred dollars valuation. The ballots used in said election will be in substantially the following form:

#### BALLOT

VILLAGE OF INNSBROOK, MISSOURI

Tuesday, the 3 day of November, 1998.

#### PROPOSITION NUMBER ONE

Shall the tax levy of the Village of Innsbrook, Missouri, be increased in the amount of Fifteen cents on the one hundred dollar valuation.

- ( ) Against fifteen cent increase in tax levy on one hundred dollar valuation.

(Place an "X" in the square opposite the one for which you wish to vote.)

The polling places for said election shall be as follows: *Interim Village Hall*

(Designate Polling Places)  
*INNSBROOK, MO 63390*

The polls at said election shall be open on the above mentioned date, at ~~each of~~ the aforesaid polling places, from the hour of 6:00 o'clock a.m. until the hour of 7:00 o'clock p.m., unless the sun shall set after 7:00 o'clock p.m. when the polls shall be open until sunset. Done by the Order of the Board of Trustees of the Village of Innsbrook, Missouri this 23 day of July, 1998.

The said notice shall be published in said newspaper once each week for three consecutive weeks on the same day and each week. The first publication of said notice shall be made at least twenty-one (21) days before and the last publication shall be within two weeks of the date of said election.

Section 5. That the Village Clerk be and is hereby authorized and directed to provide the judges and clerks of said election at each of said polling places with the necessary poll books, tally sheets, ballots and other supplies required for the conduct of said election, the said ballots to be in substantially the following form:


(Place an "X" in the square opposite the one for which you wish to vote).

Section 6. That the said election shall be held and conducted and the result thereof canvassed in all respects in accordance with the laws of the State of Missouri governing villages.



