The Fernshire Drive homeowner with an outstanding yard issue has been notified in writing that the Board may implement Article V of the Declarations of Covenants and Restrictions for Wexford West HOA which states: 'The Associations shall have the right to provide exterior maintenance to any lot that does not comply to Section 19 of the WWHOA Restrictions'. Further action is still being reviewed.
- 3. A new pump motor needs to be installed in the pump house; Bob Heal spoke with the contractor and Steve Cybulski will follow-up.
- 4. A fence panel has popped out on CR 1; arrangements will be made to fix it.
