Consider and act upon amendment of award of contract between City of Whitewright TWDB CWSRF Wastewater System Improvements Project WTW.001 to include generator at the lift station site at an additional cost of \$61,069.62 AND to award alternate to replace all the force main all the way to the manhole at an additional cost of \$13,587.58. The project budget for construction was \$401,500.00; however, there is \$83,075.00 in contingency funds to cover these costs at no additional expense to the city.
  - Councilmember John Simon moved to approve and act upon the amendment to include generator and to award alternate as stated above. Councilmember Sarah Beth Owen seconded the motion. Motion carried 4-0.
