Destiny Parent and Family Engagement Policy

- o Parents are given results of local assessments as needed
- Link on the school website to Destiny School report card
- Information on assessments is shared at Open House/Meet the Teacher Night
- B. The school will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
 - Title I holds a Book Fair yearly to enhance literacy strategies for all students
 - Free materials are provided to all students and parents to promote literacy at Open House/Meet the Teacher as well as through our parent resource center
 - Parents are offered contact information for all professional staff
 - Students are given progress updates as needed
 - Information is available through the district website to all parents (www.mydestinyschool.org)
 - All students are provided with a student handbook or agenda
- C. The school will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Title I staff meeting
 - Parent Teacher Organization meetings
 - Administrative team meetings
 - Surveys
- D. The school will, to the extent feasible and appropriate, coordinate and integrate parental involvement activities with programs such as Head Start, public preschools and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

- Instructional materials given to students for academic use at home
- Open House/Meet the Teacher Night provided for families
- Kindergarten orientation prior to the start of school to transition students to kindergarten. Staff meet with Head Start teachers for transition meetings
- Information is shared to parents from outside organizations

 - The school's approved ELL (English Language Learners) program is willing to assist any ELL family
 - School events will be well publicized
 - Communication with parents will be encouraged
 - Flyers and reminders are sent home to invite parents and children to the Annual Title I Family Night
