Others present included were District Manager Kevin Ritz Cochran, Project Manager TJ, and Paul Carr, a potential new board member.

Approval of Agenda: Director Tom Lammert motioned to approve it, and Director Angela Berga seconded a motion to approve the agenda as presented. The motion passed unanimously.

Approval of Minutes: Tuesday, August 20, 2024. Director James Lehnhoff motioned to approve. Director Tom Lammert seconded a motion to approve the minutes as presented with noted corrections. The motion passed unanimously.

Update on Capital Improvement Projects:

Highway W Watermain Extension

- The target is to bid this out in the winter, and the target start date will be TBD. We must talk to local landowners about potential risks around this start date.
- Cochran was authorized to begin work at the May board meeting.
- The topographic survey has been completed.
- Cochran is working on finalizing an alignment.
- Cochran has already started working on easements.

Lower Byrnes Mill Watermain Extension

- Cochran is working on updating two new easements due to field changes. Cochran has the needed fieldwork to finish said easements.
- KJU has requested a change order. Reviewing and discussion.
- The district awarded the project to KJU, Inc. in the amount of \$819,651.50
- KJU has received approval to pull the construction permit from the City of Byrnes Mill. KJU will pay for the necessary bonds with the city.
- KJU began construction on June 3, 2024.
- PWSD6 received the contractor's application for a \$329,812.21 payment.

Managers Reports

Emergency Repairs:

- 8/8 Main repair on the property line of the sod farm and corn field split on 6".
- 8/9 Main repair on Carter Drive leaking at a bell by a valve replaced pipe and installed new valve.
- 8/12 Leak on 4" ductile iron in 16" steel easing under Old Gravois at Crest Manor trailer court. Installed 60" of a new pipe with two bends on the main side.
- 8/15 There was a small split on the service line under the road. Dogwood Lane pulled a new line from the main to the meter pit.

Maintenance Repairs

- Repaired 1 old meter service
- Installed 3 new meter settings

Other

Northwest Project:

 P&M has begun the water main relocation in front of the schools. Originally, we planned to relocate only 560', but as co. Construction began, and we decided to add 1000', a total of 1,560', and relocate all of the main alongside Gravois Road to avoid future issues.

Highway W River Crossing Project:

• Kevin contacted the county a month ago to see if there was additional funding from ARPA. They said no but have since contacted Kevin. They said a few entities backed out of their ARPA grant and advised the Water District to apply. If approved, that could provide 25% funding for this project.

Regulatory Compliance:

- Disinfection residuals averaged 1.0 mg/L free residual
- 8 Monthly routine Bacteriological (Bac-T) clean
