WITNESSETH, THAT THE SAID GRANTOR, in consideration of the sum of ONE HUNDRED DOLLARS (\$100.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents Sell and Convey unto GRANTEE, its successors and assigns, the REAL ESTATE, situated in the County of Anderson, State of Kansas, and legally described as follows:

#### TERMINATION OF LEASE AGREEMENT AND TRUST INDENTURE

This Termination of Lease Agreement and Trust Indenture dated as of October \_\_\_, 2016 among the City of Garnett, Kansas (the "City"), The Board of Trustees of the Anderson County Hospital, a county hospital organized pursuant to K.S.A. 19-4601 et seq. (the "Company") and Security Bank of Kansas City, as trustee (the "Trustee").

- A. The City has previously issued its of \$500,000 principal amount of Tax-Exempt Industrial Revenue Bonds (Anderson County Hospital Medical Office Building Project), Series 2006A and \$145,000 principal amount of Taxable Industrial Revenue Bonds (Anderson County Hospital Medical Office Building Project), Series 2006B (the "Bonds"), pursuant to a Trust Indenture dated as of December 15, 2006 (the "Indenture"), between the City and Security Bank of Kansas City (the "Trustee"), and used the proceeds of the Bonds to construct a Project (as defined in the Indenture).
- B. The City leased the Project to the Company pursuant to a Lease Agreement dated as of December 15, 2006 (the "Lease Agreement"), between the Company and the City, and the Company and the City filed for record a Notice of Lease Agreement and Operating Agreement recorded December 19, 20016 in Book 81 at Page 216 and an Assignment of Lease recorded December 19, 2006 in Book 81 at Page 217.
- C. The Company, the City and the Trustee entered into various other documents relating to the Bonds (the "Other Bond Documents"), a complete set of which is contained in the Transcript of Proceedings Relating to the Issuance of the Bonds (the "Transcript").
- **D.** The Company has made provision for payment of all amounts payable under the Lease Agreement, including payment of all outstanding Bonds and all fees, taxes, penalties, costs and expenses of the Trustee and the City, and the City is conveying the Project to the Company;

## NOW, THEREFORE, THE CITY, THE TRUSTEE AND THE COMPANY DO HEREBY STATE AND DECLARE:

That as of October 1, 2016 the Lease Agreement, the Indenture and the Other Bond Documents shall terminate and be of no further force and effect. The real property located in Anderson County, Kansas, affected by the Lease Agreement and Trust Indenture is described in **Exhibit A** attached hereto and incorporated herein by reference and such real property is hereby released from the lien and effect of the Lease Agreement, the Indenture and the Other Bond Documents.
