By signing this agreement you shall be deemed a riding member of Tri-County Riders for the entire show season for any subsequent Tri-County Riders function in which you or your child may participate. In signing this release, please bear in mind that when riding horses that there is a certain element of danger involved and that you will be riding at your own risk. Also all riders under the age of 18 MUST wear a helmet at all times while mounted. This is a Tri-County Riders rule. Adults who choose not to wear a helmet do this at their own risk. Signing this release also releases Tri-County Riders of all liability if a adult chooses not to wear a helmet. Minors Must Have Form SIGNED BY PARENT/LEGAL GUARDIAN. NO EXCEPTIONS. I have read and will abide by all the above rules and conditions and all Tri-County Riders rules.
