**TITLE: APPROVAL OF AMERICAN RESCUE PLAN ACT OF 2021,  
APPLICATION FOR STATE SMALL BUSINESS CREDIT INITIATIVE  
FOR TRIBAL GOVERNMENT FUNDING**

**WHEREAS,** the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council; and

**WHEREAS,** in accordance with Article II, Section I (b), to represent the Summit Lake Paiute Council in negotiations with Federal, State and local governments, and other corporations, associations, partnerships or individuals, in matters of welfare, education, recreation, and social services; and

**WHEREAS,** the Summit Lake Paiute Council is authorized pursuant to the Articles of Association of the Summit Lake Paiute Tribe, Article II, Section I (j), to determine their own rules of procedure; and (k), to take such actions as are necessary to carry into effect any of the foregoing duties; and

**WHEREAS,** the American Rescue Plan Act (ARPA) appropriated funding for Tribal governments in the State Small Business Credit Initiative (SSBCI) for the purpose of promoting tribal enterprises; and

**WHEREAS,** promote small business financing programs, including capital access programs, loan participation programs, loan guarantee programs, collateral support programs, and venture capital programs; and

**WHEREAS,** preliminary funding allocation for Summit Lake Paiute Tribe of Nevada is \$435,536 which includes the base allocation (Section 3003 (b)) and Very Small Business Allocation (Section 3003(f)); and

**NOW THEREFORE BE IT RESOLVED,** the Tribal Council of the Summit Lake Paiute Tribe does hereby submit Resolution SL-44-2021 to accept all allocated and supplemental funding allocated under the American Rescue Plan Act of 2021, State Small Business Credit Initiative.
