You will need to describe an area in your life where you demonstrated leadership and overcame obstacles either through your school, social or family life. Requirements:

- Be seventeen (17) years of age or older at the time of application.
- Be a legal resident of Westmoreland or Fayette counties, Pennsylvania
- Be a high school senior and currently enrolled in an accredited college or university.
- Meet the annual per person family/household income listed below (please check one):
 - 2 persons \$33,820.00
 - 3 persons \$42,660.00
 - 4 persons \$51,500.00
 - 5 persons \$60,340.00
 - 6 persons \$69,180.00

Applicant Eligibility

To be eligible for the Pediatric Associates of Westmoreland Scholarship fund, applicants must be a Pennsylvania resident, be a high school senior, have a minimum cumulative 3.5 to 4.0 GPA and enrolled in an accredited college or university in the 2020-2021 academic year. Selection is based upon financial need, academic ability, demonstrated community and school service, and recommendations.

Applicant must be a U.S. Citizen or Permanent Legal Resident of the United States. Employees of Pediatric Associates, affiliates and subsidiaries, participating advertising and promotion agencies, and members of said employees' immediate family and those living in the same household of employees are not eligible.

Applicant must be a current senior in high school.

Applicants attending military academies are ineligible for this scholarship.

Distribution of Payments

The winning recipient will receive a one-time, \$4000 scholarship to be applied to undergraduate tuition for the 2020/2021 academic year. Funds are provided directly by Pediatric Associates of Westmoreland. Payments are issued by Pediatric Associates of Westmoreland, made payable to the student's approved college or university and mailed after July 15, 2020 directly to the accredited college or university last designated by the student.

Winner Selection and Announcements

The winner will be announced July 15, 2020. A team of judges will review all entries after the deadline of June 30, 2020. Each entry will be judged on creativity, intricacy, and relevance to the prompt, as well as how they promoted their post.

Conditions of Award

If any other funds pay entirely the undergraduate tuition for the student's 2020/2021 academic year, the student is no longer eligible to receive this scholarship and will forfeit the award.

College/University Approval

The institution must be accredited and listed on the official website of the [U.S. Department of Education](#). Applicants attending military academies are ineligible for this scholarship. All school transfers are subject to accreditation approval.

Responsibilities of Recipients

The recipient must be actively enrolled full-time as a freshman, and for the entire academic year without interruption, barring illness, emergency, or military service. It is the recipient's responsibility to verify receipt of funds with their designated institution and notify Pediatric Associates of Westmoreland should the award check not arrive on or after 30 days from the issue date.

Permissions

Pediatric Associates of Westmoreland reserves the right to alter or discontinue this program at any time without notice.
